BE IT FURTHER RESOLVED that Franklin Township hereby commits to address its third round fair share obligation with a newly adopted housing element and fair share plan within one year after the effective date of COAH's third round methodology and rules; and

BE IT FURTHER RESOLVED that Franklin Township shall either file the newly adopted housing element and fair share plan addressing the third round obligation with COAH or petition for a third round substantive certification prior to the expiration of this extended second round substantive certification.

BE IT FURTHER RESOLVED, by the Township Committee that this Resolution shall take place immediately.

Carol Jacobs was present in reference to the Ayres property, the tree was struck by lightning and what is the status on clearing the property. Survey determined that the tree is on Jacob's property due to where the roots are from the tree. Mayor Riggs noted to go with the survey since certified by an engineer where the tax map is not. Per Attorney Zaiter township can go in to secure the property on motion by Larry Adams and seconded by Earl Sigler. Zaiter notifying family of Ayres. Nevitt will check on the flood plain. Jacob's asked whose responsibility to clear sidewalks in front of property. Attorney Zaiter noted that we do not own the property as of yet so we don't have to clear sidewalks, Carol will have her husband contact Denise reference to shoveling and how much he would like to get for doing this until property is owned by township.

Asbury Asst. Fire Chief and member John Murray presented to the committee that the new fire truck is having major problems with the drive/rear steer on slippery surfaces and loose traction. Murray spoke with salesman to replace the steering axle with a tandem. Mayor Riggs expressed concern not to drive the fire truck out to Michigan for repair due to tacking on the mileage and this problem needs to be addressed immediately, gather information who the salesman is, manufacturer and maintenance records and get to Attorney Zaiter to draft a letter on how/who responsible for cost of this malfunction.

Attorney Update:

Rocky Brook I: Bond can be used to finish up the job, might have to contact Bond Company to see what they want to do. Site Plan need to review this at Municipal Building.

Merrill Creek CAN System: Richard Lewkin surprised that Mayor not behind this system. Zaiter informed committee that the letter received is just needing a signature from Roger Bulava noting that he was given this not the ratification of the system. Denise will let Roger know that he can sign the letter.

Jim Onembo: Ok to proceed on Bartek summons? Can only sight property owner, per Attorney Zaiter send certified letter giving adequate time to clean up and send to both Bartek's to cover all basis.

Howard Bryan: Department of Public Works Superintendent, advised the mayor and committee that Tom Pineno who works at General Motors, in union, benefits stop if he doesn't show for sitting at union office or can do community service in the township in which he resides. Has his own medical insurance. Audrey spoke to a gentleman in Belvidere who handles community service said Tom would not be covered if he was in a Department of Public Works truck. Denise will contact Brown & Brown to see if we can clear this matter up. Mayor Riggs noted that the Department of Public Works did a great job in snow storm last week, she received phone calls from people living in developments wondering when they will be gotten to. Howard to prepare a letter to go out possibly with the directory how streets are prioritized in a snow storm.

Keith Matlock, Downright Floors did a presentation of various flooring material for the warehouse advising committee on what they should look to purchase when ready to resurface. Hardwood and Engineered Wood does not recommend, won't withstand abuse. Pergo, floats. Should go with a VCT Tile, Metro Tile or Vinyl Tile, comes in all colors, flooring seen in schools and malls. Didn't come up with a price at this time but when township goes out to bid will provide. Keith also noted that the warehouse should be kept at 55 degrees and to choose colors/pattern prior to going out to bid since a design vs. a flat color will change a price. Care for the floor should coat with wax prior to first use.

Committeeman Adams noted a question with an invoice for Alert Pagers, 8 pagers. Mayor Riggs noted that this is nothing above and beyond the budget it is a line item, Dawn advised Fire Department that money was still left. Also noted that the Department of Public Works did a great job with snow storm, did receive a complaint of a broken mailbox on Bryan Road, discussed with Howard replaced pole same day, Mayor Riggs noted this was handled well.

Committeeman Ziegler noted that next year meetings will be held once a month.

Committeeman Sigler noted that the burn brush pile should receive in discretion from property owners anything bigger than say 6 feet should be turned away. Valerie noted that Howard should put this notation on the web page.

PUBLIC SECTION:

Jeff Julian stated that the Youth Association had two goals for past year; Financial Stewardship and Increased Community Involvement, they have been successful on both. Also noted that past snow storm Howard was working in a tractor without a radio, the Department of Public Works and the people just hired for snow removal all pulled together to make it work. Good Team Effort!
