Kober's Property Solar Project had a little push back from the state with Highlands issues. In Rem Tax Foreclosures, following up regularly hoping to file by early next year.

Engineer Report – No formal report submitted

Montana Retaining Wall contracts are back, and a pre-con meeting will be scheduled. Good Springs Road drainage design has been modified and working with the owners to rectify. DPW Foreman has been in contact with Tom Bartha as to their role with this matter and have spent at least a full day on site. Millbrook Road Section II a second grant was received in the amount of \$87,600. Engineer considering additional phases for this project to help reduce out of pocket cost for the township. Will need to sit down with the CFO and Foreman to address further. NRCS EWP Grant for Shurts Road and the damage after the Ida storm. This grant is specific to stream erosion and adjacent issues. An estimate will be submitted by December 20th. 25% commencement is the responsibility of the township, and we can elect to dropout before spending any money. MWA has matching funds available as well for the same project.
