Do township officials and professionals receive training and/or guidance as to what they can or cannot say? Again, Attorney echoed, possible litigation, no response given.

Pat Banes – 366 Bloomsbury Road – how much money has the township committee spent on a failed attempt of Block 58 Lot 1 endeavor? Attorney informed to send an OPRA.

Mike Zawacki – Bloomsbury Road – a procedural question, the administrator said earlier that the meeting is recorded in its entirety, why don't we post the recording or transcript on our website, instead of a condensed version of minutes which is someone else interpretation? A lot of information is being left off or not included, not to point fingers, but we need a bigger picture of what goes on at these meetings. Attorney informed that this is not a legal requirement and would put a big burden on our clerk. Not done in any other municipalities in the State of NJ and it won't be done in Franklin Township.

Rick Canale – Lime Kiln Road – just for the record, two additional tractor trailers have attempted to cross the bridge into Hunterdon County since Christmas. This is a constant problem additional signage is needed.

Brian Lopez -341 Mountain View Road - Mayor Ferri did you vote with the Land Use Board on the redevelopment for the warehouse and would that be considered a conflict moving forward? Attorney advised, no it would not be a conflict.
