First Reading/Introduction - Ordinance 2021-4

ORDINANCE 2021-4 CALENDAR YEAR 2021 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.0% unless authorized

by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Franklin Township Committee of the Township of Franklin in the County of Warren finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Franklin Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$12,341.39 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Franklin Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Franklin Township Committee of the Township of Franklin, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Township of Franklin shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$43,194.87, and that the CY 2021 municipal budget for the Township of Franklin be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Attorney Report -

Attorney Benbrook filed the Appeal to the NJDCA as to the Redevelopment of Block 58 Lot 1. Our OPRA request was filled and the documents were received from the DCA. The WC Planning Department opposed to any Redevelopment and the ADC opposed property due to preservation. The Freeholders were unaware of the letter sent in opposition by the Planning Department. A decision to our Appeal, per the attorney, advised we may see this in 2021.

Attorney informed that the Tax Foreclosures can be filed, however, there will be modest fees to do this. We should probably build this expenditure into our budget, approximately \$15,000. Attorney will order searches. As to the Heisler lawsuits they should be dismissed without prejudice.

Open Space Commission - No one present

Jim Onembo - Code Enforcement/Zoning

Mr. Onembo had nothing substantial this month to report. Committeeman Herzer inquired as to the foreclosed properties in the township. Mr. Onembo advised there are only 5 properties that remain, from our long list last year. To date we have received \$8,000.

Fire Department/EMS - Chief Jan Verkade -

Chief Verkade inquired as to the 1994 Van Ambulance and a consideration of the committee to release said Title to the Fire Department. They have an interested party, that would like to us it as a mobile home. The ambulance is 10 years old and has had an electric fire and does not run. It will be sold as is and looking to get the value of scrap metal and use that money to purchase of equipment. Prior to the ambulance removed off their lot, the lights and squad emblem must be removed. Attorney advised the committee this makes sense to proceed.
