Dave Leary spoke on behalf of numerous residents present as to a water problem involving 1,4-Dioxane contamination. 17 Properties, to date, located on Herleman, Willow Grove & Good Springs Roads have been identified. The DEP supplies 1 gallon of water daily to each household. They cannot be connected to the water line, due to water-age issues and there are no treatment options for residential properties. One of the homes in the area sold for a fraction of its value, as the unfortunate purchaser was not able to obtain a mortgage without potable water. Committeeman Butler will address this matter with our State Assembly Members. Committee Herzer will be the liaison to the people.

Flo Kitner has a chicken problem involving her neighbor. Besides being located so close to her home they have attracted rats. Attorney Benbrook informed earlier he will be addressing our current Chicken Ordinance. Zoning Officer Onembo will also investigate this matter.
