RESOLUTION 2023-57

RESOLUTION PROVIDING FOR THE FINANCING OF A SPECIAL EMERGENCY APPROPRIATION FOR EXTRAORDINARY EXPENSE FOR THE REPAIR AND RECONSTRUCTION OF VARIOUS ROADS DAMAGED BY THE JULY 16TH STORM OF THE TOWNSHIP OF FRANKLIN, IN THE COUNTY OF WARREN, NEW JERSEY BY THE ISSUANCE OF SPECIAL EMERGENCY NOTES OF THE TOWNSHIP

BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF FRANKLIN, IN THE COUNTY OF WARREN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) as follows:

SECTION 1. The Township of Franklin, in the County of Warren, New Jersey (the "Township") has heretofore finally adopted, on August 14, 2023, a resolution entitled: "A RESOLUTION OF THE TOWNSHIP OF FRANKLIN, IN THE COUNTY OF WARREN, NEW JERSEY, PROVIDING FOR A SPECIAL EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-54 IN THE AMOUNT OF \$2,500,000 FOR EXTRAORDINARY EXPENSE FOR THE REPAIR AND RECONSTRUCTION OF VARIOUS ROADS DAMAGED BY THE JULY 16TH STORM" (the "Resolution"), for the purpose of appropriating the sum of \$2,500,000 as a special emergency appropriation pursuant to N.J.S.A. 40A:4-54.

SECTION 2. The Township hereby determines to finance the special emergency appropriation referred to in Section 1 herein by the issuance of Special Emergency Notes of the Township, which may be renewed from time to time, as provided by law. Special Emergency Notes of the Township are hereby authorized to be issued in the principal amount of \$2,500,000 pursuant to the Local Budget Law. At least 1/5 of all such Special Emergency Notes, and the renewals thereof, shall mature and be paid in each year, so that all such Special Emergency Notes shall have matured and have been paid not later than the last day of the fifth year following the date of adoption of this resolution.

SECTION 3. All Special Emergency Notes issued hereunder shall mature at such times as may be determined by the chief financial officer, subject to the limitations set forth in Section 2 hereof. The chief financial officer shall determine all matters in connection with Special Emergency Notes issued pursuant to this resolution, and the chief financial officer's signature upon the Special Emergency Notes shall be conclusive evidence as to all such determinations. All Special Emergency Notes issued hereunder may be renewed from time to time subject to the

provisions of N.J.S.A. 40A:4-55(b). The chief financial officer is hereby authorized to sell part or all of the Special Emergency Notes from time to time, at no less than par and accrued interest, at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the Special Emergency Notes pursuant to this resolution is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the Special Emergency Notes sold, the price obtained and the name of the purchaser, and such report shall be entered in full on the minutes of such meeting.

SECTION 4. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the Special Emergency Notes authorized by the Resolution and hereunder. The Special Emergency Notes shall be direct, unlimited obligations of the Township. The powers and obligations of the Township to pay any Special Emergency Note issued pursuant to this resolution and the Local Budget Law shall be unlimited and the Township shall have the power and be obligated to levy ad valorem taxes upon all taxable property within the Township for the payment of such Special Emergency Notes and interest thereon, without limitation of rate or amount.

SECTION 5. All Special Emergency Notes issued pursuant to this resolution shall be executed by the Chief Financial Officer and the Mayor of the Township, and shall be under the seal of the Township and attested by the Township Clerk. Such officers are hereby authorized to execute and deliver all documents necessary or convenient in connection with the issuance, sale and delivery of the Special Emergency Notes.

SECTION 6. The Township reasonably expects to commence the purpose described in the resolution referred to in Section 1 hereof, and to advance all or a portion of the costs in respect thereof, prior to the issuance of Special Emergency Notes hereunder. To the extent such costs are advanced, the Township further reasonably expects to reimburse such expenditures from the proceeds of the Special Emergency Notes authorized in Section 2 hereof.

SECTION 7. This resolution shall take effect immediately.

Attorney Benbrook reminded the township they can treat this as an emergency without going out for bids starting repairs and/or fix and can ratify at our next township meeting. A delay due to storm dames with the Dioxane project preliminary design getting out to NJAW/fire chief/railroad/county will submit this month the design to.

Attorney – Attorney Benbrook has the Land Use Board files on the Tigar Tract to pursue an injunction. Coordinating with Zoning Officer to pursue an injunction. A Tort Claim was received as to the 7Up Bottling Company, Block 15 Lot 11.02. This matter started with our old tax collector as to redemption figures and the property was sold at a tax sale. The attorney is working now with the current tax collector to rectify the situation. Mr. Benbrook will also put a list together of those properties foreclosed on previously (In-Rem Foreclosures) auction them off as well as the old Playmaker's property on Rt. 57, designated as a re-development area. Looking to move on with this in the fall to get properties back on the tax rolls.

Open Space – no one present

Zoning Officer – Jim Onembo – Welcome to Broadway sign is in bad shape, DPW to take a look at this and try to repair. A discussion ensued as to preserved farm properties and holding weddings on the property. The Ag Board met does not overrule township zoning per Mr. Onembo. Attorney Benbrook will coordinate with the Land Use Board Attorney establishing regulations/guidelines, conditional/permitted uses, hours, parking, etc. per the committee's consensus as well as notification to the township of an event. The attorney will also look into sample ordinances from neighboring municipalities providing flexibility to the farms, but the township will have some control.

Fire Department/EMS – Chief Dave Brown – The EMS station received major storm damage and all apparatus has been relocated to fire stations. All walls in the building had to be removed from the floor up but no contents were lost. They are working with their insurance company on the repairs of the building and coordinating with our OEM as well. Deputy Mayor Guth commended the Fire/EMS for a great job done during the rain/flooding storms. The Chief advised that had more than 40 manhours with pump details as well as road assessments. Annual maintenance of equipment proved to go over well, and any repairs were easily fixed. There was a mass casualty accident today on Route 22 and St. James Avenue. We were able to staff an ambulance with two EMTs to respond. A tractor trailer turned over on two cars. The Chief inquired if there was an ordinance to respond to nuisance fire alarms. There is a home that they are dispatched to frequently when the power goes out, due to power failure, the fire alarm will sound, and the fire department will be dispatched. Attorney Benbrook will research ordinances.

OEM/911 Coordinator – OEM Shawna Tabert – Public Assistance has been approved and reimbursement will come from a split of 75%/25%, the squad building will fall under this. As far as Individual Assistance, we have had 21 residents fill out the survey from Franklin Township, nothing official at this time, waiting to hear. Temporary Debris Management Assessment (TDMA) was turned in in the beginning of July. Foreman Biel has been keeping track of the DPW manhours as well as fire/ems volunteer hours to apply for reimbursement as well as OEM hours. Working with the municipal engineer obtaining estimates for Montana/Millbrook Road and various roads damaged by the storm and working on the bonding. Working with Senior Aging and division gone through entire county list, one resident may have an issue and need additional assistance. Team Rubicon Memorandum, volunteer organization, contract has been executed for future disasters with debris removal, medical support, clean-ups, and muck-outs to get a home ready for professional repair. Small business loans are coming down from FEMA as well. Homeowners receiving denials from their insurance carriers need to attempt to go through their homeowner's insurance first whether denied or not. If no flood insurance, then you need to be persistent with your homeowner's insurance carriers if they are telling you that your furnace or hot water heater are not covered under their HO policy. Attorney Benbrook as a courtesy can assist if need be. Cleanup vouchers expire August 31st through the Pollution Control Finance relating to the storm. Mayor Toretta thanked OEM Tabert for all her efforts/time during the flood. Mayor Toretta thanked Shawna for all she has done and right on top of it getting the most for Franklin Township.

DPW- Joe Biel – Report submitted/filed – The backhoe has broken down requesting the committee's permission to rent from Powerco. The township committee's consensus to proceed with renting while ours is being repaired.

Recycling Coordinator - absent

Committee Reports:

Bonnie Butler – A discussion with our tax collector as to the mailing of our stormwater management flyer with our tax bills to receive credit. A new vendor will be mailing out our tax bills this year as the old vendor no longer does this. The tax collector will be looking into replacing PNC with Unity Bank for the Tax Account. Feels we can generate with Unity Bank possibly \$30-40K interest on township funds in this bank.

Rich Herzer –Nothing further to report.

David Guth – Nothing further to report.

Mike Ferri – Nothing further to report.

Michael Toretta – Nothing further to report.

Open Public Session:

At approximately 8:09 p.m. Mayor Toretta opened the floor to the Public. Unanimous vote.

Keith Stockton – What is the determination/plan with Millbrook Road will be closed? What is the plan to redivert the creek back to its original home as well as debris removed from it. The contractor will cleanup as well as the rediversion of the creek per Engineer Finelli. Deputy Mayor Guth informed that there are still a lot of unanswered questions and coordination with the State of NJ as to the creek repair/cleanup. Millbrook Road will and will be closed throughout this year. The attorney informed Millbrook Road needs to be meticulously engineered and will have to go out for bid since it will cost over \$2million. OEM has a short hold harmless agreement if work is to be done on private property. Mr. Stockton asked how are you going to attack to clear the roads in the winter, no room for plows to turn around? DPW has a pickup truck that will be able to handle this during the winter.

Wayne Ferguson – Thanked the committee members for all they do, he sat on the committee for 9 years and never had an emergency like this. There are approximately 22 residents from where he lives to the top of Millbrook Road. It used to be 1 mile for an ambulance or firetruck to respond to his house and the other houses on this road, now for him since the storm/damages it is 6-7 miles. Have we thought about this? Mutual Aid is in place to help respond from different avenues of the township for fire/ems services and they are quite aware of this. Debris from the river, is there a voucher for the landfill, see the clerk she will issue.

Mary McGuire – Concern if the water will flow again out of the farmer field onto Millbrook Road and reflood Route 57 and homes in the area of the flooding. Per mayor, storm drains are now opened, and an excavator was brough in to divert the water flow from the field. OEM reiterated furnace/hot water heaters should respond with homeowners' policies, attorney will help if needed. Public Assistance threshold is \$16million, Individual Assistance there is not a number it is a percentage formula per OEM.

OEM informed residents again that your personal homeowners' policies should respond to damaged furnaces/hot water heaters and Attorney Benbrook can provide support if needed. Governor has declared an emergency for Warren County to start the ball rolling with FEMA funds.

Hearing no other public comments, the floor was closed at 8:27 p.m.

At this time, the committee will commence into an Executive Session on motion by Committeeperson David Guth and seconded by Rich Herzer at 8:27 p.m.
