### 2024 Professional Contracts-

All contracts have been received and ready for execution at our re-organization meeting. The Land Conservancy is requesting a rate per hour increase from \$100 to \$115. The Municipal Auditor is requesting a \$1,000 increase. The Land Use Board Attorney is requesting a \$500 minimum meeting fee from \$350 last year. The Municipal Attorney is requesting a modest \$1,500 increase from last year's contract. The Public Alliance Insurance Coverage Fund-2024 Fund final renewal assessment for Franklin Township will be \$117,607 which represents a 13% increase over last year's assessment of \$103,776 as per Charlie Frinzi.
